Facility setup: July 27, Thursday 9am to 12pm

Member setup:July 27 Thursday 12pm to 8pm and July 28, Friday 8am to 12pmPassing judging:July 28, Friday 12pm to 2pm (not open to public or members)Show judging:July 28, Friday 2pm to 5pm (not open to public or members)Opening ceremony:July 29, Saturday 8:30am. Members/guests (not open to public)

Show and sale: July 29, Saturday 9am to 5pm and July 30, Sunday from 9am to 4pm (open to

public and members)

Plant removal & tear down: July 30, Sunday from 4pm to 6pm **Vendor pickup:** July 30, Sunday from 4pm to 6pm

Eligibility:

All current members of HSCSS. Junior division members 16 years and younger who are children or grandchildren of current HSCSS members. No commercial growers may enter.

Agreement:

Members showing plants must accept all rules and regulations of HSCSS.

All plants put in show must remain in place until show ends unless deemed otherwise by show chairs.

All plants entered must have been in member's possession 6 months prior to show date (must own plants before Jan. 28, 2023) except in the decorative section.

Pot size:

Measurement is determined by largest inside dimension. Not diagonal.

Plant labels and tags:

Cannot be visible during show.

Staging:

Should reflect your best effort to enhance aesthetic value of the plants.

Natural top dressing is required. Artificially colored dressing can be used only in Decorative section.

Passing standards:

On July 28 at 12 pm all entries will be reviewed by passing judges to ensure each is displayed properly, in its correct class, conforms to show standards, and qualifies as a succulent, which is defined as a plant that comes from a habitat that is arid or semi-arid at least part of the year and has evolved a means to survive periods of drought.

Novice and Advanced entries

This year, all plant specimen entries in Sections 4-11 will be categorized and judged as either Novice or Advanced. Novice- Exhibitor has won fewer than 20 blue ribbons total in specimen plant classes in past shows. Use beige entry card.

<u>Advanced</u>- Exhibitor has won 20 or more blue ribbons total in specimen plant classes in past shows. Use blue entry card.

Sections 1-3 - Decorative/Photography/Educational. Novice/Advanced status does not apply. Use white entry card. Sections 4-11 – Specimen plants. Judged as Novice or Advanced per definition above. Use either beige or blue entry card.

Section 12 - Junior Division. Novice/Advanced status does not apply. Use yellow entry card.

Section 13 - Member Plant Display. Class will not be judged. Use extended white entry card.

Entry cards (See sample cards below):

The card identifies your entry to the judges and to the public.

Each entry in a class must have a card.

You will receive your entry **number** when you turn in your entry form.

Your name goes in the exhibitor's area. In the junior section, the child's age also goes here.

Under your name write your entry number and class number.

The correct or accepted botanical name(s) and country of the plant's origin is required on card except in decorative section.

Leave the "Passed by" section empty.

Below the perforation, repeat the entry number and section number.

When placing Entry card on the table near your plant(s), fold the top portion back to hide your name, so judges cannot identify who owns the plant(s).

Awards:

Class ribbons: Entries in each class may be awarded 1st, 2nd, 3rd, or Honorable Mention ribbons.

Judges may opt to give more than one 1st, 2nd, 3rd, or Honorable Mention ribbons or no ribbons at all.

A "First Time Exhibitor" ribbon is awarded to each member entering for first time in our show.

Special awards:


Judges will award one special award to each of the classes below.


Eligibility requires entrant to have received a blue ribbon in its class.

These awards are:

- CSSA Education Award: CSSA provides trophy for best educational exhibit. There must be at least 2
 entries to receive award.
- The Dorothy Weitz award is given for the best cactus in the show.
- The Dorothy Weitz award is given for the best succulent in the show.
- The Bob Harris Best Bonsai Award is given for best bonsai in the show.

All photos must be matted; no frames allowed.

Photo no larger than 8" x 10"; Mat no larger than 11" x 14".

If possible, include name of plant, date, location, where, and when taken and any other relevant information.

Table space for each entry is limited to 24" deep and 36" wide.
